Application for re-entry permit for Greenland**Uses**

You can use this form to apply for a permit to re-enter Greenland (re-entry permit).

It can be necessary for you to apply for a re-entry permit if you plan to leave Greenland and return later, and if you

- are staying in Greenland based on procedural residence,
- have been granted a temporary residence permit and do not have a residence card or
- have been granted a residence permit and have lost your residence card.

If you are not in possession of a residence card

If you have lost your residence card you must complete and sign a declaration of lost residence card. The declaration can be obtained from the police.

If the Danish Agency for International Recruitment and Integration (SIRI) has issued a residence card to you, which you have not received, you must complete and sign a declaration stating this.

How to apply

1. Complete and sign this application form.
2. Submit the form in person to the police or in the citizen centre of the Danish Agency for International Recruitment and Integration.

Bring your passport

Remember to bring a valid passport when you submit your application.

How to submit the application

You must submit the application form in person in order for us to verify your identity

You must submit the application for a re-entry permit well before you need to travel – **at the latest one month before.**
