Application for family reunification (spouses)

Contents

This application packet contains two forms:

- Form 1 – *Application for family reunification of spouses in Greenland*
- Form 2 – *Information form for applicant's spouse in Greenland*

Both forms are to be used when applying for family reunification. "Family reunification based on marriage, registered partnership or cohabitation" should be understood to mean the granting of a residence permit based on

- marriage
- cohabiting partnership *or*
- registered partnership

In the instructions below, the word "spouse" is used as a general term to refer to a spouse, a registered partner or a cohabiting partner.

Who uses which form?

In order to apply for family reunification of spouses, Form 1 and Form 2 must be submitted.

Form 1 is to be used by the spouse who **does not** currently have the right to reside in Denmark together with his / her spouse. He / she should:

- Fill out Form 1.
- Submit Form 1 and any required documentation to a Danish embassy or consulate or at a police station in Greenland. A list of police stations is available at www.politi.dk. If the applicant is in Denmark the form can be submitted at the Immigration Service's Citizen Service.

Form 2 is to be used by the spouse who already **has** the right to live in Greenland.

Instructions

- Fill out Form 2.
- Submit Form 2 and any required documentation to the Danish Immigration Service.

If both spouses live in Greenland the forms should be submitted together.

The specific instructions and the required documents are given on the first page of each form. There is a checklist at the back of the forms that can be used to keep track of whether they have been filled out correctly and whether all the required information has been included.

Can I submit an application in Greenland?

If the applicant is legally in Greenland, the application can normally be submitted there. Such is the case if the applicant:

- has a valid visa
- is exempt from visa requirements *or*
- currently holds a residence permit in Greenland

Instructions

When applying for family reunification based marriage, registered partnership or cohabitation, each spouse needs to fill out a separate form.

The instructions below explain how the person who does **not** already have the right to live in Greenland as a reunified spouse (the applicant) applies for a family reunification residence permit.

1. Fill out and sign Form 1. Follow the instructions in the form.
2. Submit Form 1 together with any required documentation to a Danish embassy or consulate in the country where you live. If you are in Greenland, you can submit the form at a police station. A list of police stations is available at www.politi.dk.

What documents should I include with my application?

The following documents should be submitted with Form 1:

- A copy of your passport (all pages with information, including cover)
 - One passport photo. Please affix the photo to the personal data card in Appendix 1
- A marriage certificate (copy or original with authorised translation to Danish or English, if necessary)
- Documentation of cohabitation (required only if you are not married)

What other documents are required?

You also need to bring your passport when submitting your application so the authorities can verify your identity.

For a faster reply

Your application will be processed with the shortest possible caseprocessing time if you and your spouse fill out Forms 1 and 2 correctly and include the required documentation.

A. Sworn declaration of correctness

I solemnly swear that the information in this application is correct and complete.

If the information is later found to be false or incomplete, I am subject to the following penalties in accordance with Section 161 of the Danish Criminal Code, cf. Section 40 of Ordinance No 184 of 14 February 2025 (Application of the Aliens Act in Greenland):

- fine or imprisonment for up to two years
- I can be required to repay the expenses incurred by the Danish state as a consequence of the false information
- my residence permit can be revoked in accordance with Section 19 of Ordinance No 184 of 14 February 2025

B. Declaration of consent – release of information required for processing my application

I consent to allowing the Danish immigration authorities obtain and release information about my private affairs if it is necessary in order to process this application, cf. Public Administration Act Sections 28 and 29, cf. Ordinance No 1188 of 27 December 1994 (Application of the Public Administration Act in Greenland). The information can be gathered from or released to other Danish and foreign public authorities, including the police.

Such information includes:

- previous criminal proceedings against me
- information about my family
- verification that the documents submitted with my application are genuine

I also consent to giving authorities contacted by the Danish Immigration Service while processing my application permission to gather information about my private affairs in order to respond to the enquiry.

C. Notification that information can be released to Danish intelligence agencies and prosecuting authorities

The information and documentation you submit with your application can be released to Danish intelligence agencies and the public prosecuting authority, cf. Section 45 a and Section 45 c of Ordinance No 184 of 14 February 2025. This may take place either at the initiative of the immigration authorities or at the request of the intelligence services or the prosecuting authorities.

The prosecuting authority will be able to use the information to evaluate whether there are grounds for prosecuting you for crimes committed in or outside Denmark, to identify victims or witnesses of a specific crime, or to assist foreign law enforcement authorities.

D. Notification that some information will be released to Greenlandic authorities

Danish immigration authorities are permitted to release certain information to the Self-Rule authorities or to the Greenlandic Police, cf. Public Administration Act, Section 28, Paragraph 3, cf. Ordinance No 1188 of 27 December 1994.

Such information includes:

- the grounds for issuing you a residence permit
- any waivers granted

The police will be informed if:

- your residence permit is revoked or not extended
- your residence permit is found to have expired or
- your residence permit is made permanent

E. Notification that Danish authorities will register information about you and your personal affairs

The information you submit when applying for a residence permit will be entered in the Danish Immigration Service's registers. The same holds true for information submitted when applying to extend your residence permit in Greenland.

The information in the Danish Immigration Service's registers will be used to answer questions about your residence in Greenland. The police will have access to the information contained in the Danish Immigration Service's registers for record keeping and verification purposes. The Ministry of Immigration and Integration will be permitted to access the Danish Immigration Service's registers in the event of a complaint.

Other authorities or organisations will receive information about you from the Danish Immigration Service's registers if the information is necessary to answer questions about your residence in Greenland.

You are obliged to provide the information necessary for deciding whether you are eligible for a residence permit in Greenland, cf. Section 40 of Ordinance No 184 of 14 February 2025. Failure to provide the information can result in a fine or up to four months imprisonment, as well as jeopardising your residence permit. You are entitled to right of access to the information about you in the Danish Immigration Service's registers, cf. Danish law No 294 of 8 June 1978 (Public Registers). F. Verification of the information you submit

The Danish Immigration Service may seek to verify the accuracy of the information included in your application. This may happen while your application is being reviewed or after you have received your residence permit.

Verification may involve contacting other authorities.

Should authorities seek to verify your information, you may be asked to provide supplementary information.

It is therefore important that you make certain that the forms are filled out correctly and that you have included the necessary documents before submitting your application.

About Sections 5, 6 and 7

Normally, you and your spouse must meet certain requirements in order for your spouse to qualify for a residence permit in Greenland. Such requirements include: that your attachment to Greenland is stronger than your attachment to any other country, that you can support your spouse/partner and that you have a suitably large residence. Sections 5, 6 and 7 ask questions relating to these requirements. They will also indicate whether you may be exempt from the requirements.

The Danish Immigration Service can, in certain instances, chose to waive the requirements even though you do **not** belong to a group that is exempt from the requirements. Such could be the case if you have custody of a child under 18 who lives in Greenland or have visitation rights. It is a requirement, however, that visitation occurs and that it meets minimum requirements. The requirements can also be waived if the spouse/partner living in Greenland suffers from a serious medical condition or is handicapped.

Determining whether you are exempt from the normal requirements for family reunification based on marriage/registered partnership/cohabitation can be difficult. If you choose not to complete Sections 5-7 or fail to submit required documentation, and the Danish Immigration Service later determines that you are not exempt from the requirements, will need to obtain further information, increasing the amount of time it takes to review your spouse's application.

For this reason, we recommend that you fill out Sections 5-7 regardless of your situation.

5. Attachment to Greenland

6. Financial support

When applying for family reunification in Greenland, you can be required to support your spouse/partner financially. If you are not married or registered partners, you could, under certain circumstances, be required to support your partner financially.

If you are a citizen of Denmark, Finland, Iceland, Norway or Sweden, or have been granted residence in Greenland according to the terms of Section 7 and 8 of the Ordinance, you will **not** be required to support your spouse/partner financially. **Nor** will you be required to assume responsibility for supporting your partner.
