Application for family reunification (other family members)

This application form can be used by:

- parents over the age of 60, who have a child who is a citizen of Denmark, Finland, Iceland, Norway or Sweden, or whose child has been granted residence in Greenland under the terms of Section 7 *or*
- family members or others with a close relation to a permanent resident of Greenland – includes parents over the age of 60, who have a child that is **neither** a Danish citizen, a citizen of Finland, Iceland, Norway or Sweden **nor** holds a residence permit in Greenland issued according to the terms of Section 7 *and*
- and if there are special arguments in favour of issuing you a residence permit

You can use this form if you would like to apply for family reunification to live with a Greenlandic resident, who is neither your spouse/registered partner/cohabiting partner nor your parent (if you are under 18).

Note: Spouses/partners should use application packet GL/FA1. Children under 18 should use packet GL/FA2.

Contents

This packet contains two forms:

- Form 1 – *Application for residence in Greenland*
- Form 2 – *Information about the applicant's family member living in Greenland*

Instructions

Both Forms 1 and 2 must be submitted when applying for family reunification.

Form 1 is to be completed by the person **applying** for family reunification to live with a person residing in Greenland.

Instructions:

- Complete Form 1
- Submit Form 1 and any required documentation to a Danish embassy or consulate or to the police in Greenland. If you reside in Denmark, the application can be submitted at the Danish Immigration Service.

Form 2 is to be completed by the person who already **has** the right to live in Greenland.

Instructions

- Complete Form 2.
- Submit Form 2 and any required documentation to a Danish embassy or consulate or to the police in Greenland. If both of you reside in Greenland, you are requested to submit Forms 1 and 2 at the same time.

The specific instructions and the required documents are listed on the first page of each form. There is a checklist at the back of the forms that can be used to keep track of whether they have been filled out correctly and whether all the required information has been included.

Can I submit an application in Greenland?

If the applicant is legally in Greenland, the application can normally be submitted there. Such is the case if the applicant:

- has a valid visa
- is exempt from visa requirements *or*
- currently holds a residence permit in Greenland

When applying for family reunification, the applicant and the person with the right to live in Greenland each need to fill out a separate form.

The instructions below explain how the person who does **not** already have the right to live in Greenland (the applicant) applies for a family reunification residence permit.

1. Fill out and sign Form 1. Follow the instructions in the form.
2. Submit Form 1 together with any required documentation to a Danish embassy or consulate in the country where you live. If you are in Greenland, you can submit the form at a police station. A list of police stations is available at www.politi.dk.

What documents should I include with my application?

The following documents should be submitted with Form 1:

- if you are a parent over the age of 60, you should include a copy of your Certificate of Personal Data (birth certificate) or some other documentation of your age and relation to the person living in Greenland
- a copy of your passport (all pages with information, including cover)
- One passport photo. Please affix the photo to the personal data card in Appendix 1

What other documents are required?

When submitting your application, you will need to bring your passport so the authorities can verify your identity.

For a faster reply

Your application will be processed faster if:

- you and your family member fill out Forms 1 and 2 correctly and include the required documentation *and*
- the application appears to meet all the conditions for family reunification of spouses.

C. Notification that information can be released to Danish intelligence agencies and prosecuting authorities

The information and documentation you submit with your application can be released to Danish intelligence agencies and the public prosecuting authority, cf. Section 45 a and Section 45 c of Ordinance No 184 of 14 February 2025. This may take place either at the initiative of the immigration authorities or at the request of the intelligence services or the prosecuting authorities.

The prosecuting authority will be able to use the information to evaluate whether there are grounds for prosecuting you for crimes committed in or outside Denmark, to identify victims or witnesses of a specific crime, or to assist foreign law enforcement authorities.

- any waivers granted

The police will be informed if:

- your residence permit is revoked or not extended
- your residence permit is found to have expired *or*
- your residence permit is made permanent.

E. Notification that Danish authorities will register information about you and your personal affairs

The information you submit when applying for a residence permit will be entered in the Danish Immigration Service's registers. The same holds true for information submitted when applying to extend your residence permit in Greenland.

The information in the Danish Immigration Service's registers will be used to answer questions about your residence in Greenland. The police will have access to the information contained in the Danish Immigration Service's registers for record keeping and verification purposes. The Ministry of Immigration and Integration will be permitted to access the Danish Immigration Service's registers in the event of a complaint.

Other authorities or organisations will receive information about you from the Danish Immigration Service's registers if the information is necessary to answer questions about your residence in Greenland.

You are obliged to provide the information necessary for deciding whether you are eligible for a residence permit in Greenland, cf. Section 40 of Ordinance No 184 of 14 February 2025. Failure to provide the information can result in a fine or up to four months imprisonment, as well as jeopardising your residence permit. You are entitled to right of access to the information about you in the Danish Immigration Service's registers, cf. Danish law No 294 of 8 June 1978 (Public Registers). 4. copy of your Certificate of Personal Data (birth certificate) – required only if the applicant is a parent over the age of 60
5. other documents as stated in the application form
